

BACKGROUND

The 2030 Agenda for Sustainable Development recognizes the important role of youth in achieving Sustainable Development Goals (SDGs) and calls for action against the challenges faced by young people that limits their economic, social, and political inclusion. Today, young people are connected, creative, informed, and persuasive. They are responding to the challenges of today with innovative approaches, contributing fresh ideas, creating the world they want, and driving human development for themselves and their communities. The COVID-19 pandemic further unleashed an unprecedented global crisis, disrupting the lives of millions and creating long-lasting socio-economic impacts that risk reducing the productive potential of an entire generation.

The Youth Co:Lab Summit 2023 in Bangkok, Thailand, co-organized by UNDP and Citi Foundation, will serve as a key milestone for the regional youth empowerment agenda by positioning young people and their innovative ideas, front and center to solve the region's most pressing challenges. As we celebrate young entrepreneurs' agility and resilience in responding to these unprecedented times, we must also meet the moment and step up our collective efforts to support young people and their transformative solutions to lead the way in our journey beyond recovery towards 2030. The 2023 Summit is envisioned to highlight, encourage, and celebrate the role of youth in our crucial Decade of Action, aligning on "Inclusive Entrepreneurship", showcasing and inspiring youth action from underserved communities, as well as youth contributing to solutions to support the most excluded and hardest to reach groups to leave no one behind.

The government track at the 2023 summit will focus on "Policy Experiments for the Inclusive Entrepreneurship Ecosystem". It will convene policymakers from across the region in an interactive and dynamic setting to ideate, design, and refine innovative policy experiments that foster an enabling environment for all young entrepreneurs.

Strategic Intelligence Hub (SIH) formed in 2022 is a community of practice and learning- co-curated by United Nations Development Programme (UNDP Asia Pacific), Commonwealth Secretariat, International Labour Organization (ILO), Islamic Development Bank (IsDB) and the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP). Since its foundation at the Youth Co:Lab Summit 2022 in Singapore, the Hub has facilitated thought leadership development on critical themes and trends identified by policy-makers who attended the 2022 Summit. Using a three transitions approach (economic, skills and mental model transitions), key future policy trends for the youth entrepreneurship ecosystem were identified. These included enabling an inclusive youth entrepreneurship environment through strengthening the data ecosystems and evidence bank, facilitating digital access of all entrepreneurs to fully leverage the potential of a tech-driven future of work, and building the capacity of young entrepreneurs to actively lead the green and blue transition agendas across the region.

A series of webinars were arranged on these themes throughout the year which were informed by strategic intelligence briefs. These briefs were developed and reviewed through a crowdsourcing approach where SIH members, policymakers and wider stakeholders who attended the webinars were invited to steer and provide guidance on the technical content and examples. Based on the situated knowledge and practical insights gained through the process, 2023 Summit will focus on collective intelligence of the policymakers and development practitioners by showcasing inspiring success stories and innovative initiatives, encouraging dialogue, and fostering collaboration for effective policy development on youth entrepreneurship. The discussions will be facilitated by a policy action toolkit developed to support the policymakers as a live document/ journal of experiences and reflections gained throughout the Summit.



These policies need to be an integral part of the wider set of strategies and policies for structural transformation and sustainable development, making coherence, coordination, and the whole of government approach essential.

As a proponent of global development, the Commonwealth has a long-standing track record in supporting youth entrepreneurship in member states. This includes the formation of networks of young entrepreneurs through the establishment of the Commonwealth Alliance for Young Entrepreneurs (CAYE). CAYE has played an important role in building the business and soft skills of young people in member states as well as providing an avenue for young entrepreneurs from across the Commonwealth to network and communicate.

At the Commonwealth Heads of Government Meeting 2022, leaders declared 2023 as a the "Year of Youth", which is now being commemorated with a focus on youth-led action for sustainable and inclusive development across the 56 members states of the Commonwealth.

The Commonwealth Secretariat in partnership with the United Nations Conference on Trade and Development (UNCTAD), is in process of updating the Youth Entrepreneurship Policy Toolkit 2023 for policymakers and private sector ecosystem leaders looking for solutions to challenges in removing barriers to entrepreneurship, accelerating entrepreneurship success, and capitalizing on opportunities. Currently, the Commonwealth in collaboration with UNDP and IsDB is also working directly with countries in the region, such as Maldives, Pakistan and Brunei Darussalam in conducting the diagnostic studies of Entrepreneurial Ecosystems in these countries.

I am pleased to be associated with the Summit and to represent The International Labour Organization (ILO) on the strategic intelligence hub for youth entrepreneurship ecosystem in Asia and the Pacific and I welcome all participants.

The Covid-19 Pandemic is on the wane and that is good news, although we must remain vigilant. So many young people were affected by the pandemic and the job market has not returned to pre-pandemic levels. So, youth employment in the region remains high. Even before Covid-19, youth unemployment has been a concern among practitioners and policy makers. We accept that young men and women are the key to our future development which must be transformative and sustainable. Yet many of them seem to be left behind, and struggle to find decent employment opportunities.

Young people are our future. We must have clear policies for youth on job creation and other programmes that allow them to earn a livelihood in a decent and constructive way. If we do not do this, many young persons can fall through the cracks. The ILO remains committed to the promotion of decent work among our nation's youths and we are guided by the ILO follow-up action plan on youth employment 2020–2030, in collaboration with multiple partners, including through the UN Global Initiative on Decent Jobs for Youth. The private sector has a critical role to play in working with the youths in programmes such as apprenticeships, on the job capacity development and development of entrepreneurial skills. So that there needs to be constant discussion between the government, the private sector, workers union and other CBO's and NGO's. Consultation and social dialogue remain the key.

In summary, we need policies and programmes which can release their potential for creativity and innovation and provide solutions to the sustainable development challenges which confront us. These challenges such as climate change or digitalization, the platform economy or SME development will remain with is for some time. We need a just transition that leaves no one behind.

Through collective efforts in addressing many issues, the hub will provide a platform for increased impact on youths and youth entrepreneurship in Asia and the Pacific.


Partners Vision Board for Design and Launch of Strategic Intelligence Hub

JULY 2022

The government track sessions at the Youth Co:Lab Summit in 2022 engaged over 14 government representatives in scoping out the vision and governance structure of the strategic intelligence hub and ideate south-south collaboration ideas on youth entrepreneurship policy programming within their country contexts and at the regional level. UNDP Bhutan and the country representatives presented findings of the ethnographic diagnostics research they administered for understanding the national youth entrepreneurship ecosystem and inspired other countries to also develop evidence-led policy actions in this regard. A reflection panel was conducted with private sector leaders from Samsung Electronics and Intel Corporation to highlight the need for the future of work and how young entrepreneurs could be supported through national and regional policy-making and targeted programming fostering public-private partnerships. The National Youth Council Singapore also arranged a showcase for the government representatives where they got an opportunity to interact with the senior council leadership and seek inspiration from the range of interventions being undertaken at the national level.

The sessions achieved to create a dedicated community which is willing to support the strategic intelligence hub lift off and seek opportunities through which the youth entrepreneurship ecosystem is further strengthened in Asia and the Pacific context.

Following policy change trends were identified for in the broader transition areas of skills, mental models and economic aspects:



Alternative Financinggrowth of innovation ideas vs. onboarding of private sector

Upskilling/reskilling- opportunity for job creation and inclusivity vs. lack of specialist training opportunities

Digitalisation- gig economy, women entrepreneurship, remote/home-based work opportunities

Green/ Blue jobs- sustainability linked careers in demand vs. limited policy uptake

One of the aims of the hub in its pilot year was to curate insightful and meaningful discussions around emerging policy themes in this space which would allow fostering a collaborative effort for youth entrepreneurship growth by the policy stakeholders, particularly showcasing lived experience of South-South co-operation. In this regard, government representatives and founding partners have been invited to express interest to curate policy discussions with key audiences and target stakeholders at national or regional levels on the following three thematic focus areas during 2022–2023.

- Digital access of young entrepreneurs
- Green transition areas for young entrepreneurs
- · Inclusive data ecosystem for young entrepreneurs

For each of these themes, webinars/ collective intelligence workshops were curated followed by a crowd sourcing exercise to write a strategic intelligence brief on each theme. Summary sheets are provided in the next section.

SUMMARY SHEET 1:

Building the Resilience of Youth Entrepreneurs through Digital Inclusion

Regional cooperation, knowledge sharing, technology transfer, and harmonization of policies can contribute to a conducive environment for youth entrepreneurship. Case studies such as the She Loves Tech Accelerator Program, Startup India initiative, Alibaba Entrepreneurs Fund, and Lazada's LazStar program highlight successful implementations of policies and programs supporting digitally-led youth enterprises in the region.

Strengthening Data Ecosystem for Inclusive Youth Entrepreneurship

A systems thinking approach can be valuable in achieving an inclusive data ecosystem. By understanding the interconnected and interdependent nature of different factors influencing entrepreneurship outcomes for young people, systems thinking can help identify leverage points for change and design interventions that address barriers and create a more inclusive ecosystem.

Mapping the data ecosystem, collecting comprehensive data, identifying entry points in the ecosystem, promoting collaboration and partnerships, updating legislative frameworks, and building capacity are recommended actions to enhance inclusive data collection and analysis. Monitoring and evaluation should also be prioritized to ensure effective and sustainable impacts of interventions.

In conclusion, addressing the data inclusion needs in youth entrepreneurship is crucial for creating an inclusive and supportive ecosystem in the Asia-Pacific region. A comprehensive approach that considers the interconnected factors and addresses the identified challenges can help foster inclusive youth entrepreneurship and promote equitable and sustainable development.

State of the Ecosystem for Youth Entrepreneurship in Bangladesh

This study produced by Youth Co:Lab in partnership with Islamic Development Bank and Startup Bangladesh Limited provides data-driven recommendations to strengthen the enabling environment for youth-led enterprises and amplify their potential in Bangladesh. This is the first research conducted using Youth Co:Lab's new youth entrepreneurship ecosystem diagnostic framework.



State of the Ecosystem for Youth Entrepreneurship in Indonesia

Young people dominate the unemployed population in Indonesia: three-quarters of unemployed people were youth in 2019 and COVID-19 has further exacerbated the challenges young people face. UNDP – under the Youth Co:Lab initiative co-led by UNDP and Citi Foundation – the Islamic Development Bank (IsDB) commissioned this study to provide data-driven recommendations to strengthen the ecosystem for youth entrepreneurship in Indonesia.




